12-010271 on 06/17/2012 at 01:24 hours, Bradley Charron 08/08/1985 of 297 West Rd, Bowdoin, was arrested for assault on an officer. Officers were called to 160 Brunswick Rd, for a report of man banging on the door. When Officer Staples arrived he found an intoxicated male wearing nothing but his boxer under shorts. While trying to get Charron to leave he assaulted a Sagadahoc Sheriff's deputy who had responded to assist Richmond Officer Josh Staples

Charron was taken to Mid-Coast Hospital to be cleared for jail, and then was transported to Two Bridges Jail
